NOTES:

- The above unaudited results have been reviewed by the Audit Committee and subsequently approved by the Board of Directors of the Company at their respective meetings held on 12th February, 2019. The Statutory Auditors of the Company have reviewed the said results.
- 2. The entire operations of the Company relate to three broad operating segments viz. "Ferro Alloys", "Power" and "Mining".
- 3. Exceptional Items for the quarter ended 31st December, 2018 amounting to Rs. 3.47 crore consists of expected credit loss on investment of Rs. 10 crore in Non-Convertible Redeemable.

 Cumulative Preference Shares.
- 4. Special Leave Petitions (SLP) filed by Utkal Coal Limited (UCL', a Subsidiary of the Company) before the Honbie Supreme Court in respect of (i) change of end use of UCL's coal block Utkal 'C' (Bidding matter) and (ii) compensation for land and mine infrastructure of Utkal 'C' (Compensation matter) were withdrawn by UCL in the preceding quarter, as because (ii) the Central Government issued orders for the auction process of Utkal 'C' along with five other blocks, to be allotted to Government companies and the auction of Utkal 'C' is underway and (ii) UCL is hopeful of an amicable resolution of the compensation matter with the Government of India and expects the compensation amount to be finalised shortly. Pending finalisation of the said Compensation matter, no accounting adjustments have been made by UCL in it's books of account and no provision is deemed necessary against the Company's net exposure in UCL as at 31st December, 2018 amounting to Rs. 111.42 crore invested as equity and Rs. 263.46 crore given as unsecured loan.
- 5. In view of the circumstances detailed above in Note No. 4 and considering the probability that the Company will collect the consideration to which it is entitled to, with effect from 1st October, 2014 the Company has postponed recognition of income from interest on unsecured loan given to UCL. Due to this, profit before tax for the quarter and nine months ended 31st December, 2018 is lower by Rs. 8.24 crore and Rs. 27.20 crore respectively. The interest income would be considered as revenue of the period in which it is properly recognised.
- 6. Previous year/periods' figures have been rearranged/regrouped, wherever considered necessary, to make them comparable with those of current period.

Review Report to

- 1. We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of Indian Metals and Ferro Alloys Limited ('the Company') for the quarter and nine months ended 31st December, 2018 ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Circular CIR/CFD/CMD/15/2015 dated November, 30th 2015 and Circular No. CIR/CFD/FAC/62/2016 dated 5th July, 2016. This Statement, which is the responsibility of the Company's Management and approved by the Board of Directors in it's meeting held on 12th February, 2019, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" as prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on the Statement based on our review.
- 2. We conducted our review of the Statement in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
- Based on our review conducted as mentioned in paragraph 2 above, nothing has come
 to our attention that causes us to believe that the accompanying Statement, prepared
 in accordance with the aforesaid Indian Accounting Standard and other recognised
