- (vi) The Company had on the basis of the register of members and the list of beneficiary owners made available by the depositories, completed the dispatch of the notice of the meeting along with the relevant annexures referred thereto, postal ballot form, proxy form, attendance slip, etc. to the equity shareholders of the Company (holding the equity shares as of the cut-off date, i.e. July 20, 2018) on Wednesday, August 1, 2018 and had also published an advertisement in this regard, in English language in Business Standard (Odisha Edition) and translation thereof in Oriya language in Pragativadi, Odisha edition on August 3, 2018.
- (vii) The e-voting was disabled and blocked by NSDL for voting on September 3, 2018 at 5:00 p.m.
- (viii) The equity shareholders were required to send the completed and signed postal ballot forms which reached me on or before 5:00 p.m. on September 3, 2018. I have not accepted any postal ballot form after 5:00 p.m. on September 3, 2018.
- (ix) On Tuesday, September 4, 2018, at the venue of the meeting convened pursuant to the directions of the Hon'ble NCLT, at the end of the discussion, the Chairman of the meeting directed conducting of the voting for the equity shareholders who were present at the meeting but who had not cast their vote earlier through the postal ballot or the e-voting platform provided by NSDL.
- (x) I first counted the votes cast through poll at the venue of the meeting. The votes cast through poll at the venue of the meeting were reconciled with the records maintained by the Company and NSDL and the authorizations/ proxies lodged with the Company.
- (xi) I then counted the votes cast through the postal ballots and unblocked the votes cast through the e-voting of NSDL in the presence of Mr. Suryasnata Rath and Mr. Premananda Barik, who are not in employment of the Company.
- (xii) The postal ballot forms and the e-voting including votes cast at the venue of the meeting through poll, which were incomplete and/ or which were otherwise found to be defective have been treated as invalid.




